#### **DELIVERABLES**

The Photographer will supply the client with: 10 hours approximately of reportage (from the preparation of the bride and groom to the fun of the party), unlimited consultations prior the wedding, preview of 10 images within the first 10 days after the wedding, approximately 300 retouched images in low and high resolution. Booklet edited by the Photographer in line with their style. The format of the booklet is 15x21cm, it has 36 pages and it is printed on warm 100gsm paper, with a hand stitched spine and a choice of 4 different colours for the thread and cover.

#### ADDITIONAL TERMS AND CONDITIONS

The Client agrees to give the Photographer sufficient warning of key events at the wedding to give the Photographer time to prepare (i.e., bouquet toss, cake cutting, speeches, etc.).

The Photographer will endeavor to get photographs of as many guests as possible, which may be limited by guests' cooperation in having their photo taken.

The Client agrees that the Photographer shall be given precedence in taking photographs over guests with cell phone, cameras and other devices. The Photographer cannot be held responsible for lack of photographs or poor quality of photographs if guests are interfering with the Photographer's work.

The Client acknowledges the Photographer may be limited in scope by rules of the location of the ceremony and/or reception. (i.e., flash photography may not be allowed within a Church).

The Client gives permission to the Photographer to exhibit the images of their wedding reportage in public domains such as their wedding photography website (www.marryme.es) and Instagram account (marryme\_as) for promotional purpose only.

## **COPYRIGHT**

The Photographer shall maintain the copyright of all photographs. The Photographer grants the Client permission to make copies of the images for personal use by the Client and the Client's family and friends. Sale, publication, or any other commercial use is specifically prohibited without the prior written consent of the Photographer.

## **CANCELLATION**

The Client may cancel this Agreement at any time prior to the event. Upon cancellation, the Client will be entitled to a refund of any monies paid, except for the non-refundable deposit.

The Photographer may cancel this Agreement at any time prior to the event. If the Photographer cancels, the Photographer must provide a suitable, replacement photographer, subject to the Client's approval, which shall be obtained in writing. In the alternative, the Photographer shall refund all monies previously paid by the Client, including the non-refundable deposit. In the event the Photographer finds a suitable replacement photographer, the Photographer shall forward all monies already paid by the Client to the replacement photographer.

# CHANGE OF DATE AND/OR VENUE

The Client agrees to notify the Photographer by phone/email at their earliest convenience should a change of date and/or venue occurs. In situations where the new venue requires substantial travel, the Client agrees to pay for reasonable logistical expenses.

Furthermore, the Client understands that the Photographer may be unavailable on an alternate date. In such circumstances, the Client agrees to liaise with the Photographer to find a mutually agreeable solution. The Client accepts that the Client might have to forfeit some/all the money paid.

# LEGAL AND BINDING CONTRACT

This Agreement is legal and binding between the Parties as stated above. This Agreement may be entered into and is legal and binding both in Europe and the rest of the World. The Parties each represent that they have the authority to enter into this Agreement. The Parties agree that this Agreement shall be governed by the State and/or Country in which the wedding will be held.

# ENTIRE AGREEMENT.

The Parties acknowledge and agree that this Agreement represents the entire agreement between the Parties. In the event that the Parties desire to change, add, or otherwise modify any terms, they shall do so in writing to be signed by both Parties.
